## **Position Summary**

The Finance Associate will support the comprehensive financial accounting and reporting requirements of One World Surgery. This position will be supervised by the Chief Finance Officer. The is a remote position with preferred hiring markets in Chicago, IL, Minneapolis, MN, Denver CO, or Birmingham AL.

### Responsibilities:

The successful candidate will be responsible for managing the financial and accounting aspects of a multi-site global non-profit organization including, but not limited to:

- Build and improve management reports and metrics dashboards and support the monthly financial reviews
- Collaborate with SCA partner to oversee month end close procedures (cash reconciliation, preparing and recording manual and recurring journal entries)
- Reconcile cash for both sites (Dominican Republic & Honduras), identify causes of discrepancies, and create plan to prevent ongoing issues
- Analyze monthly results and provide commentary on key variances to budget, forecast, and prior periods
- Review cost analysis by program, site, surgical cost per case, identify opportunities for savings, and determine how to look at this ongoing
- Build presentations for monthly operating reviews and Board meetings
- Oversee the OWS annual audit and related tax documents
- Prepare ad hoc financial analysis and reporting requests from management
- Reconcile financial data with Little Green Light data and ensure contributions are entered into the Little Green Light Database
- Ensure the proper coding of all contributions and expenses in collaboration with the Development and Program/Operations teams



- Partner with CFO and Program/Operations lead to establish local accounting system
- Provide guidance to Honduras and Dominican teams related to financial management, oversee monthly fund requests and transfers, and review monthly expense reports
- Maintain and update financial management policies and oversee their implementation across the team
- Support the annual budgeting process across all departments and sites
- Process invoices and ensure timely payments to vendors
